Dear President Whitaker,

I am writing further to the Minister's letter dated March 28, 2019, which advised you that it was the Minister's intent to grant consent to Humber College Institute of Technology and Advanced Learning to advertise and offer an Honours Bachelor of Paralegal Studies.

The intent to grant consent was subject to the college accepting the Standard Terms and Conditions for a College of Applied Arts and Technology and the following additional conditions:

1. The Applicant Agreement Form set out as Attachment A of the Standard Terms and Conditions is signed by an authorized representative of the college and returned to the ministry within 30 days.
2. The consent shall be for:
 - A period of seven years, commencing from the date of the letter of consent. If an application for renewal of this consent has been submitted in accordance with the terms and conditions of this consent, but no decision on the application for renewal has been made at the time the current consent is scheduled to expire, the consent shall continue to be in force until the Minister issues a decision on the application for renewal.
 - Such further period following the expiration of the above-noted seven-year consent period as is reasonably required to allow students who were enrolled in the program during the above seven-year period to complete the program, (a teach-out period), should the college decide to discontinue the program. The Minister may impose such further terms and conditions during

this teach-out period that the Minister considers appropriate for the protection of students.

3. As conditions of consent, Humber is required to:
 - Submit to the ministry a report, no later than two months after consent renewal on its progress in developing a bridging course/courses to cover the gap between the non-core courses offered in the diploma versus the non-core courses offered in years one and two of the degree.
 - Submit to the ministry a report upon program renewal, tracking the performance of students admitted from either high school or the Paralegal diploma program with less than 70% GPA and compare it with the rest of the cohort.
4. The consent is specific to Humber's Lakeshore campus (3199 Lakeshore Boulevard West, Toronto, ON M8V 1K8).
5. The college shall maintain the program's conformity with all the criteria set out in the handbook of the Postsecondary Education Quality Assessment Board titled Handbook for Ontario Colleges.


Additionally, please note that granting this consent does not, in any way, indicate that growth in enrolment resulting from this consent will result in additional capital funding being granted for new instructional space.

I would like to confirm that the ministry has received and is satisfied with the signed Applicant Agreement Form.

Under the authority delegated to me in my capacity as Assistant Deputy Minister, Postsecondary Education Division, I am granting consent for Humber College Institute of Technology and Advanced Learning to offer the above-noted program in Ontario. This consent is for a period of seven years commencing from the date of this letter.
