**Re: Application from the Canadian Theological Seminary
Master of Arts (Leadership and Ministry)
Recommendation to Grant Consent**

Pursuant to section 5 (1) of the *Post-secondary Choice and Excellence Act, 2000*, the Canadian Theological Seminary applied on June 11, 2004, for consent to offer a Master of Arts (Leadership and Ministry) program. In accordance with section 5.2 of the *Act*, the Minister referred the application on July 6, 2004, to the Board for its review and recommendation. The Board's final review of the application was done in accordance with the relevant standards in its *Handbook for Private Organizations, April 2005*. The submission, the report of the quality assessment panel, and the applicant's response were considered by the Board at its meeting of January 17, 2006.

Based on:

- The applicant's submission,
- the findings of the Organizational Review Panel appointed by the Board to assess the applicant's organization against the Board's standards and benchmarks for a private organization,
- the findings of the Quality Assessment Panel appointed by the Board to assess this program against the Board's standards and benchmarks for a master degree program,
- the applicant's responses to the panels' reports,
- any additional materials provided by the applicant to the Board,
- any commitments made by the applicant during the review process, and
- the Board's assessment of the information,

the Postsecondary Education Quality Assessment Board finds that the proposed program meets the Board's standards, and the Board recommends that you grant consent to the Canadian Theological Seminary to offer a Master of Arts (Leadership and Ministry) program, to be abbreviated M.A., at its 30 Carrier Drive, Suite 204, Toronto, location.

The Board also recommends that:

- the consent holder be required to begin providing the program within 24 months from the date of the commencement of the consent;
- the consent holder advise the Minister in writing of the date of the commencement of the program not later than six months prior to its actual commencement; and
- the ending of the consent period be five years from the date of the program commencement.
