Dear Mr. Arjune:

I am pleased to advise you that, pursuant to subsection 4(1) of the *Post-secondary Education Choice and Excellence Act, 2000* (the Act), it is my intent to amend the consent granted to Conestoga College Institute of Technology and Advanced Learning on December 31, 2007 to change the name of its Bachelor of Applied Technology (Integrated Advanced Manufacturing Technologies) program to Bachelor of Applied Technology (Mechanical Systems Engineering).

All other terms and conditions of the original consent relating to the delivery of the above-noted program, as identified in the original letter of consent dated December 31, 2007 remain in force. In this regard, note that the term of the consent remains unchanged, i.e., December 31, 2012 and the consent is specific to the site at Conestoga's Doon Campus, at 299 Doon Valley Drive, Kitchener, Ontario.

The amendment to the consent is subject to the further terms and conditions set out below:

1. This consent letter is returned to me within 30 business days of the date of this letter, signed by a representative of the college authorized to bind the organization.
2. The college maintains conformity with all commitments made in writing by the college to the Minister or the Postsecondary Education Quality Assessment Board (the Board) as part of the application dated May 7, 2009 for a change to the consent of the above-named program and any additional commitments made in writing by the college during the Board's review process.
