Dear Dr. DeGennaro,

I am writing further to my letter of April 27, 2009 advising you that pursuant to subsection 4(1) of the *Post-secondary Education Choice and Excellence Act, 2000*, it was my intent to grant consent to Lawrence Technological University to advertise and offer a Master of Business Administration program in Ontario and be known by the name Lawrence Technological University in Ontario in connection with this program.

As I indicated in my letter, my intent to grant consent was subject to Lawrence Technological University accepting the terms and conditions set out in my letter, which included the Standard Terms and Conditions attached to the letter, the execution of the Applicant Agreement form, satisfactory completion of the tuition fee, financial security and trust fund forms attached to the Standard Terms and Conditions, and fulfilling of the security requirements as required under the legislation. Pursuant to my letter, the consent would be for a period of five years, commencing on the date of my written confirmation that I am satisfied with the above-noted requirements.


