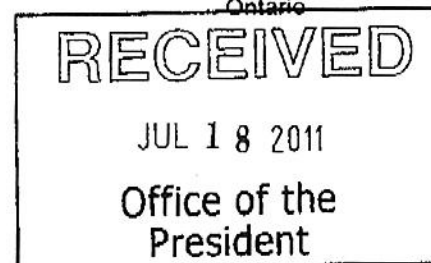

Dear Dr. Schwaller:

I am pleased to advise you that, pursuant to subsection 4(1) of the *Post-secondary Education Choice and Excellence Act, 2000* (the Act), it is my intent to amend the consent granted to State University of New York Potsdam on June 7, 2007 to extend the duration of its consent for the Master of Science in Teaching (Childhood Instruction) until May 31, 2014 upon receipt of a signed back copy of this letter.

After May 31, 2014, no degree activity for this program can take place in Ontario. Students who have not completed the program by this date will have to complete it at the State University of New York Potsdam or on line from another location outside Ontario.

The terms and conditions of the original consent relating to the delivery of the above-noted program, as identified in the original letter of consent dated June 7, 2007, remain in force. In this regard, note that the consent is specific to the site at Dominican College, 16 Empress Avenue, Ottawa.

The consent is subject to the further terms and conditions set out below:

1. This consent letter is returned to me within 30 business days of the date of this letter, signed by a representative of the university authorized to bind the organization.
2. The university maintains conformity with all commitments made in writing by the university to the Minister or the Postsecondary Education Quality Assessment Board (the Board) as part of the university's original application for consent for the above-named program dated September 9, 2002 and any additional commitments made in writing by the university during the application review process.

The above-noted amendment to the consent is effective as of the date I receive the sign-back of this letter. Ministry staff will provide confirmation in writing of the date of receipt of the sign-back letter.




